

INVITATION TO BIDS

2. The procurement shall be completed in accordance with PPRA rules, 2014 (amended up to date) on a Single-Stage, One Envelope bidding procedure.

A complete set of Bidding Documents (in English Language) is available in the office of undersigned and can be purchased at the cost of **Rs. 500/-** deposited in National Bank of Pakistan on a written request through authorized person of bidder during office working hours (09.00 AM to 05.00 PM) from the date of publication of this Tender Notice on PPRA and Energy Department websites up to one day before the closing day.
4. The estimated price for procurement of items for this tender is **Rs.1,759,000/-** including all applicable duties & taxes. (**Rs.1,359,000/- for Lot#01 and Rs.400,000/- for Lot#02**)
5. The procuring agency reserves the right to cancel the tender without assigning any reason thereof as per PPRA rules.
6. The procuring agency reserves the right to increase or decrease the quantity of the bid items before issuance of work order to the successful bidder.
7. The Bidder shall furnish as part of his bid, a Call Deposit/Pay Order equivalent to 02% of the total estimated cost for each LOT as Bid Security in favor of “**Director Technical/ Project Director, Reconciliation Cell, Energy Department Govt. of the Punjab Lahore**”. Any bid not accompanied by acceptable bid security shall be rejected being non-responsive.
8. Bidders will quote each LOT separately and can also participate in one or more LOTs or whole tender.
9. Completed bids in all respect (One Original & One Copy) in sealed envelope, should reach the office on or before **17.08.2023 at 03:00 PM**. The tender will be opened on the same day by a notified Committee at **03:30 PM** in the same venue in the presence of bidder’s representatives who may like to attend the Bid Opening meeting.
